

#### DESCRIPTION OF PARCEL I:

A parcel of land situated and being located in the Northwest ¼ of the Southeast ¼ and the Northeast ¼ of the Southwest ¼ of Section 9, Township 7 South, Range 12 West, First Judicial District of Harrison County, Mississippi and being more particularly described as follows, to-wit:

BEGINNING at the Southeast corner of the said Northwest ¼ of the Southeast ¼; thence run North 00 degrees 00 minutes 00 seconds East 1329.60 feet along the east line of the said Northwest ¼ of the Southeast ¼ to the Northeast corner of the said Northwest ¼ of the Southeast ¼ and the north line of the said Northeast ¼ of the Southwest ¼ to the easterly margin of County Farm Road and to a point on a curve concave to the east having a radius of 454.01 feet; thence run southerly 30.63 feet and through an angle of 03 degrees 47 seconds 56 seconds along the easterly margin of County Farm Road and said curve to a point being South 22 degrees 13 feet along the easterly margin of County Farm Road; thence run South 24 degrees 09 minutes 45 seconds East 164.82 feet along the easterly margin of County Farm Road; thence run South 89 degrees 31 minutes 06 seconds East 164.82 feet; thence run South 00 degrees 00 minutes 00 seconds East 120.00 feet; thence run South 89 degrees 31 minutes 06 seconds East 420.18 feet; thence run South 00 degrees 00 minutes 00 seconds East 184.07 feet; thence run South 88 degrees 25 minutes 23 seconds East 257.48 feet to the POINT OF BEGINNING.

BEGINNING at the Southeast corner of the said Northwest ¼ of the Southeast ¼; thence run North 00 degrees 00 minutes 23 seconds West 257.48 feet; thence run North 00 degrees 00 minutes 00 seconds West 184.07 feet; thence run North 89 degrees 31 minutes 06 seconds West 420.18 feet to the POINT OF BEGINNING; thence continue North 89 degrees 31 minutes 06 seconds West 200.00 feet to the easterly margin of County Farm Road; thence run North 27 degrees 08 minutes 32 seconds West 135.43 feet along the easterly margin of County Farm Road; thence run South 89 degrees 31 minutes 06 seconds East 261.79 feet; thence run South 00 degrees 00 minutes 00 seconds East 120.00 feet to the POINT OF BEGINNING.
